# **Top Tip! Balancing your VAT**

There are a number of councils who are VAT registered who have made a VAT claim but HMRC has added interest to the VAT claim and thus the VAT does not balance. If you do get this, you will need to only code the VAT claim to the VAT control and code the difference to an income code i.e. interest received or misc income. If in doubt, please contact <u>Rialtas Support</u> who will go through and do a journal if necessary.
